

## **CONFLICT OF INTEREST CODE FOR THE OAKLAND-ALAMEDA COUNTY COLISEUM AUTHORITY**

**This Conflict of Interest Code is promulgated under the authority of the Political Reform Act, Government Code section 81000 et seq., which requires all state and local government agencies to adopt and promulgate conflict of interest codes. Regulation 2 Cal. Code of Regs., section 18730, as adopted by the Fair Political Practices Commission contains the terms of a standard conflict of interest code; which may be incorporated by reference and may be amended by the Fair Political Practices Commission after public notice and hearings to conform to amendments in the Political Reform Act.**

**Therefore, the terms of 2 Cal. Code of Regs., section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference and, along with the attached Appendix in which employees are designated and disclosure categories are set forth, constitute the Conflict of Interest Code of the Oakland-Alameda County Coliseum Authority.**

**Designated employees other than the Authority members shall file their statements of economic interests with the Authority's Auditor who will make the statements available for public inspection and reproduction. (Gov. Code section 81008.) The original of each Authority member's statement of economic interests shall be forwarded to the Authority's Auditor and a copy shall be retained by the Authority's Auditor.**
