### SUBJECT: DEPARTMENT CONFLICT OF INTEREST CODE

Dear Board Members:

#### **RECOMMENDATION:**

Approve the District Attorney Conflict of Interest Code as amended September 28, 2018 to include four new classifications that will be governed by the Conflict of Interest Code.

#### SUMMARY/DISCUSSION:

This recommendation is submitted in compliance with a memorandum received from the Clerk, Board of Supervisors Office dated September 19, 2018, asking the District Attorney to review its Conflict of Interest Code and make any amendments necessary. The Conflict of Interest Code is promulgated under the authority of the Political Reform Act, Government Code section 81000, et seq., which requires all state and local government agencies to adopt and promulgate conflict of interest codes.

The current Conflict of Interest Code approved for the District Attorney includes a list of employee classifications that are required to submit Annual Statements of Economic Interests. The District Attorney conducted a review of that list and identified four additional classifications that were created and/or added to the District Attorney's budget since the list was last approved. Those classifications include: Assistant Chief of Inspectors (job code 8544); D.A. Admin Chief of Staff (job code 3310); Admin Services Officer (job code 0221); and Program Administrator II (job code 0312). The District Attorney has submitted its amended Conflict of Interest Code to include these four new classifications.

## CONFLICT OF INTEREST CODE FOR THE ALAMEDA COUNTY DISTRICT ATTORNEY'S OFFICE

This Conflict of Interest Code is promulgated under the authority of the Political Reform Act, Government Code section 81000, et seq., which requires all state and local government agencies to adopt and promulgate conflict of interest codes. Regulation 2 Cal. Code of Regs., section 18730, as adopted by the Fair Political Practices Commission after public notice and hearings to conform to amendments in the Political Reform Act.

Therefore, the terms of 2 Cal. Regs., section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hearby incorporated by reference and along with the attached Appendices in which employees are designated and disclosure categories are set forth, constitute the Conflict of Interest Code of the Alameda County District Attorney's Office.

Designated employees shall file their statements of economic interests with the District Attorney's secretary who will make the statements available for public inspection and reproduction. (Gov. Code section 81008.)

Persons in this category must disclose those investments and business positions in business entities, sources of income and interests in real property which provide or directly support the provision of expert services or the provision of office supplies and office support services in Alameda County or derive income from the provision of those activities in Alameda County.
