SUBJECT: APPROVE MODIFICATION OF THE CONFLICT OF INTEREST CODE FOR THE SHERIFF'S OFFICE

Dear Board Members:

RECOMMENDATION:

Approve the amended Conflict of Interest Code for the Sheriff's Office to remain in compliance with regulations in the Political Reform Act of 1974.

DISCUSSION/SUMMARY:

California Government Code 87306.5 requires local agencies to submit their Conflict of Interest Code to the reviewing body via a biennial report identifying changes in its code, or a statement that their code is not in need of amendment. The Sheriff's Office has reviewed its Conflict of Interest Code and has determined that our Agency's code should be amended to modify positions whose classification and duties requires a conflict of interest statement.

The Sheriff's Office has completed a review of the Conflict of Interest code as required by your board. After completing this review, it was determined that the Conflict of Interest Code's list of designated positions needs to be amended to include additional positions, as well as remove the individual assigned name, as Sheriff's Office staff may transition into and out of the identified positions during a particular year. Agency staff will ensure anyone occupying an identified position will be tasked with completing the required conflict of interest statement.
