**SUBJECT: APPROVE THE MODIFICATION OF THE CONFLICT OF INTEREST CODE
FOR THE SHERIFF'S OFFICE**

Dear Board Members:

RECOMMENDATION:

Approve the amended Conflict of Interest Code for the Sheriff's Office to remain in compliance with regulations in the Political Reform Act of 1974.

DISCUSSION/SUMMARY:

California Government Code 87306.5 requires local agencies to submit their Conflict of Interest Code to the reviewing body via a biennial report identifying changes in its code, or a statement that their code is not in need of amendment. The Sheriff's Office has reviewed its Conflict of Interest Code and has determined that our Agency's code should be amended to modify position(s) whose classification and duties requires a conflict of interest statement.

The Sheriff's Office has completed the Biennial Review of the Conflict of Interest Code as required by your Board. After completing this review, it was determined that the Conflict of Interest Code's list of designated positions needs to be amended to delete positions that will not filled and to add positions that need to be designated. The positions of Captain of Glenn Dyer Jail and the UASI Commander need to be deleted because they will not be filled in the Sheriff's Office anymore. The positions of Warrants and Records Captain, SOG Caption, SRJ Compliance Captain and two (2) Financial Services Officers need to be added due to their capacity to make or participate in making governmental decisions that may possibly have a material effect on any financial interest.

The proposed revision affects only the attached Appendix A of Designated Positions.


FINANCING:
