SUBJECT: APPROVE AN AMENDMENT TO THE ALAMEDA COUNTY CHILD SUPPORT SERVICES DEPARTMENT CONFLICT OF INTEREST CODE.

RECOMMENDATION:

Approve an amendment to the Alameda County Child Support Services (ACCSS) Conflict of Interest Code to update the classifications of designated filers required to adhere to the Conflict of Interest Code governed by the Political Reform Act.

DISCUSSION/SUMMARY:

Under the Political Reform Act, government code section 87100, public agencies are mandated to institute a conflict of interest code. The code requires disclosure of investments, interest in real property, and income through the annual filing of the Statement of Economic Interest (Form 700) by ACCSS officers, employees, and agents that participate in agency funding decisions to ensure that direct or indirect financial interest does not exist in the financial transactions they affect.

The persons required to adhere to the adopted code are identified using guidance from the Political Reform Act, Government Code Section 1090. These designated filers are listed in the Appendix of Designated Positions within the ACCSS Conflict of Interest Code. Moreover, the type of assets required to be reported by the filers are listed in the Appendix of Disclosure Categories within the code.

Thus, the Appendix of Designated Positions has been amended to reflect the current officers, employees, and agents of ACCSS required to adhere to the adopted code by removing one ISM position and adding one position of the Policy Manager.

FUNDING:

There is no fiscal impact on the County for approving this recommendation.

The amended Code and List of Designated Positions meets the County's 10x goal pathway of **Eliminate Poverty and Hunger** in support of our shared vision of **Thriving and Resilient Populations**.
